2022 PASSION PLAY OBERAMMERGAU - This is truly a must see event! Join Premier World Discovery for a once in a decade performance to see the "Oberammergau Passion Play". In 1633, the residents of Oberammergau, Bavaria, Germany, vowed that if God spared them from the bubonic plague ravaging the region, they would produce a play thereafter every 10 years depicting the life and death of Jesus. The villagers believed they had been spared and they kept their part of the vow when the play was first performed in 1634. Witness the 42nd Passion Play in Oberammergau rescheduled from 2020 to 2022 on this journey plus explore some magnificent sites in Germany & Austria.
